

ABSTRACT

This paper looks at Curriculus Planning and be exponent from the perspective of Instructional accuraces. It irrongly buggests the full integration of Instructional Resources into the Curriculum Design activities from the planning state. The types of Instructional Resources and their criteria are selection or production have been highlighted. The Flanning-Programm-log-Budgeting System (PPBS) has been suggested as one important planning and management strategy that can facilitate the proposed integration. The need for establishing an Educational Technology section in the State Ministry of Education has also been litressed. Some suggestions have been offered on the problems related to political and financial support, personnel, resources weilability and utilization.

The resulting 6-3-3-4 educational system therefore demands, among other things, functionalism and relevance in content, materials and methodology. Above all, it demands accountability on the part of all aducational personnel. These demands cannot be effectively mot unless effective instructional strategies are developed and employed. Those strategies involve the findings in the field of Educational Communications and lechnology.

In the context of the problems sketched above, Nigeria's concern about the success of the Senior Secondary Cohool (S.S.S) in be easily justified. The government's commitment to the 3 secondary education system is clearly spelt out in the 4 stional Policy on Education, 1981, Section 4(18). The rel ted 4 trategies can be found in sub-sections 19(6) and 21. In 4 section to teachers' role sub-section 24(6) states:

Teachers will be required to participate more in the production and assessment of educational materials and teaching aids, the planning and development of school buildings and furniture, and the evaluation of technical innovations and new techniques.

in teacher preparation, explasts is also placed on structional resources. For example, paragraph 81 in section emphasizes teachers' role in "planning and development of urriculum". Also in section 10(6%), the objectives of Educational Services which subsume Enstructional Resources among ther services, are:

INSTRUCTIONAL RESQUECES:

The "teaching aid or apparatus concept", according to kanhi (1982) Thas failed to create appropriate awareness of the role of instructional resources" in formal education in ligeria. This can be attribute, to the fact that at the planning stage, instructional resources are not integrated Into the curriculum so its deve opers and implementers find It difficult to bring these requireds into the instructional mterprise. Lack of integration partly accounts for the current practice of teaching most lessess with only the chalkboard (which in most cases are gressly abused) and the textlerage (which, where evailable, obsoluteence or intelance contect be completely ruled out). The tractice can hardly produce Effective and successful implementation of the S.S.S. corriculum. his is more so now that the need for Educational Technologists, Infrastructure, coney, political support and proper attitude wards innovation have conspir 4 to compound the already complex problem of integration.

Instructions resources reler to all resources (data, people, message, materials, levices techniques and settings) which may be used by learners in is dation or in combination, with formally and informally to propose the facilitate the equisition and evaluation of knowledge, skills and morals through the life-long processes of eaching and learning (MECT, 1977). To ple often return to them as autio-vise of mids, teaching aids, educational media, courseware, etc. Their classification too is varied; print and non-print, projected and non-projected, hardware and software, big media and little

itedia, etc. - all reflecting to me is attributes, cleatic mature and the evolutionary growth of educational technology.

The Frint resources constitute one of the most widely accessible and most utilized class of instructional media. They include textbooks, workbooks, reference materials, agazines, journals, manuals, newspapers, programmed materials, tion, teachers' handouts, etc. According to Aldern etc. al. (1970), learners recall only 100 of what they read. This observation emphasizes the need to introduce other forms of ledia into the instructional programme.

The non-print can be classified into the audic resources which include the radio, audiotopes, records and their players, relephone and public address system. According to Alcorn, et, al. (1970) only 20% of what is learnt by hearing can be is invalled. The next class of non-print is the visual resources. Mis class takes care of boards, models, graphs, diagrams, maps, harts, picture; and opaque, slide, filmstrips, overhead and till film projection. 30% of what is seen can be recalled. The third class of non-print is the audiovisuals which include the filmoscund, television, videotape, audic-slide presentaion, etc. Learners can recall 50% of what they hear and see. When resources which do not fall neatly into any of the above re classifie! (Inyang-Abia, 1984) as phenomenal resources and mipulative-criterion resources. The phenomenal resources molude community establishments, rescurce persons, Iramatizaion and demonstration, trips, on a unusual phenomena. The 'd anipulative-criterion resturces are those that learners directly interact with and manipulate in order to acquire the competence nd mastery; they include rescurces such as guitar, accordion, Malute, paintings, balls, rackets, sewing machines, cockers, roft equipment, laboratory equipment.

CRITERIA FOR 'ELECTING OR PRODUCTION

Most instructional resources, if not all, can be effective in the S.E.M. regreence. Ellective communication, teaching. and learning (and even proper evaluation of some instructional tasks) can only be facilitated and guaranteed by careful selection and skilful atilization of appropriate instructional resources by the teacher and for the Learner. Bowever, because wast instructional resources care functional, negoties or dysfunctional in different instructional situations. Heldt (1978) points out that a variety of media car we effective in attaining many objectives. Iso most objectives can also be achieved through any or a variety of media. A knowledge of criteria for selecting instructional resources for the various ispects of the S.S.S Programme would therefore be partinent and melpful. This is because rationality in resources, according to Carpenter (1971), depends upon "factors and combinations of variables that most closely approximate the desired or "the optimum relationship". Using this "best fit" approach, Gagne ind Briggs (1979) have found the following criteria useful in selecting instructional reserroes for any educational programme. Task Variables: These embody the degree to which an instructional medium better incorporates the desired learning rariables: the behavioural objectives, instructional content, Rearner activities, and evaluation techniques and instruments. 1 Then these are clearly stated, when help the teacher to select or produce appropriate instructional resources.

the the mobilized through a morely leading to an inventor. Accompanied with relevant information page as appropriate raps, photographs, contact sadresser, exterphone numbers, and other related data including instructional possibilities, rules and regulations covering visits, cost per visitor, existence of boarding and lodging facilities, these inventories, if adequately publicized could prove helpful to educators in instructional anterprise. These resources could be utilized in various ways and for moved wide variety of learning experience for beyond what any given textbook could provide to the denumer. For excepts, inviting a resource porcen to talk in tameitional religion, visiting a historic neine, or learning about poultry farming may provide a more comprehensive and more lasting experience than what a teacher with whole textback could provide. These resources are readily wailable to us, sometimes with no extra cost. All that we need to do is to mobilize and utilize them. Their selection or utilization is also subject to the criteria already specilied above.

lalues of Instructional Resources: The value of instructional tescurces cannot be overemphasized. They can be used to introduce and develop a lesson, organize and present facts and concepts, remediate instructional mit ation, review an instructional programme, evaluate a lesson or unit of instruction, and stimulate discussion or inquiry.

They help the teacher to talk less while the learners learn more, retain longer, participate more actively and whibit the desired behaviour more accurately. They can be sed to extend the instructional time. They are invaluable of individualized learning, effective in small group Instruction and vital for large group instruction.

the transfer value inherent is shem. They receive a development of attitudes and received. Inaccessible material processes or events which are helpful in understand as some tencepts and unlaciples are more accessible to the tearner mywhere. The teacher can use their to arrest and sustain lattention and interest of the clade, to help him present facts and information, teach a neepts and principles, guide thinking and promote transfer of learning. They are the burest way to develop abstract learning - a corollary of tencrete learning. If they are so useful, then what is the rationale for planning the curriculum without giving instructional resources its rightful place?

MANAGEMENT STRATEGIES AND STRUCTURAL FRAMEWORK FOR THE INTEGRATICAL

Management involves planning, administration, supervision and evaluation of men, materials and money in an effort to whiteve the desired goals and objectives of a system of an organization. This section will address itself to the fiscal and curriculum planning as they relate to instructional resources.

Planning, Frogramming and Eudgeting System (PPR) has been found (Merrill and Drob, 1977) to be very effective in long-term planning for school media services. This is because of the emphasis of this system on choice and implementation of relevant specific programmes. It also emphasizes organization and utilization of human and non-human resources in order to realize identified desirable objectives within the limits of available resources and other relevant contextual variables.

Planning: At the planning level the needs are assessed. operational objectives are determined and are integrally

related to the curriculur and other academic program as-Mat is to say that the PPBS implementation allows for the determination of needs and operational objectives. Secisions based on Who shall produce what instructional resources for whom, for what purpose and through what means? are made. These decisions need to be made at the curriculum planning phase. Programming: At this level, actual performance programmes are designed based on inputs from the learner, teacher and the reciety. The activities and the programme elements of the ichool are specified, and described in behavioural terms. The units and sub-units, general statements and detailed instructional programmes with deadlines are specified and pularized. The functions of the varibus production units and sub-units (graphics, photographic, television, school mdio, audio recording, improvisation administration, mainimance, etc.) are specified.

integrating: At the resource allocation phase, the necessary resources: money, facilities and personnel are allocated to be becomplished the already specified goals and objectives of the various programmes. Financial data are provided to import the statement of plans and programmes. Educational and research goals in financial terms are specified. Multipear plans in financial term are made. Import licence and foreign exchange are acquired for necessary bulk-purchase of spare parts of equipment and materials.

Evaluation: Evaluation is an in-built process of the PPBS.

Luch phase of the system is continuously and formatively evaluated. The summative evaluation comes after the programme deadlines. The programme is analysed and reported. Goals are revised, new objectives, programmes, procedures and training strategies are also identified based on needs.

Some atructural frameworks to facilitate the Volume leemtation and integrating instructional resources into the \$.S.S Programme are suggested below.

The existing organizational set-up where all educational lervices are merged under a single unit, "Educational Services", has failed to put instructional resources in the right persective in curriculum planning and development, despite the lital role that media play in curriculum development and implementation. It should be reviewed and expanded. An implementational Technology Unit should be set up as a matter of irgency. It has been found to be effective in Imo, Rivers, undo, Oye, among other states, where the effort of the Relevence Committee on Educational Technology (RCET) has affelded fruits.

In 1978 and 1979 this committee (RCET) submitted becommendations through the Joint Consultative Committee (J., a Education to the National Council on Education (NCE). As result, Ministries of Education throughout the Federation of approval in 1980 to create a Division of Educational charlogy and Curriculum Development. However it is surtising that in Cross River State, the Educational Services vision is hidden somewhere at Uyo. An Educational Technology alt will, to a great extent, ensure the achievement of the IS.S Programme goals, given the commitment of the personnel involved. The organizational chart for this unit is illustrate in Figure 1.

The Graphics, Photographic and Community Resources sub-

School Broadcasting Section should take care of the madio, Relevision and Audio Sub-Units. There should also be a Text-books and a Curriculum Planning and Development Section. The support Sections are the Administrative and the Mechanical. It the various sections and sub-units, improvisation should be of major consideration. Each section should be canned by committed personnel with relevant expertise and experience related to Educational Communications and Technology. Among the functions of this unit, the following should gain promitence.

- 1. To emphasize by various means, the utilization of instructional resources at all levels of our educational system.
- 2. To mobilize and produce an inventory of (and information related to) the community resources and their instructional utilization possibilities for the state.
- 3. To acquire (produce, purchase, loan, etc.), evaluate and distribute instructional resources for the state.
- 4. To mount training programmes (pre-service/in-service, etc.) for teachers in areas related to the production, selection, and utilization of instructional resources for the state.

It is pertinent to emphasize at this juncture he need for ach institution of learning (primary schools, TTCs, secondary thools, etc.) in this state to set up a school media centre here all instructional resources are kept for use in learners to teachers either "in situ" or off situation. The existing libraries in each school or college can be a good mediaus of the whool media centre. The library assistants can be offer effectively here at no extra cost, if given the basic media administration training. Only by setting up an Educational Technology action in the Ministry of Education can this function be effectively catered for.

At this juncture too, we can recall that the instructional sterials distributed by the National Educational Technology mtre (NETC), Kaduma, to most schools in this state have been ying waste because at the curriculum planning level no provision is made for enrichment programmes as offered by the NETC, frough the instructional radio.

Learning Resources Centre (L.M.C.): These are critical fablished not only for the production utilization and distibution of instructional resources but also for the training directaining of teachers and learners. They can be to the tional, state or local government levels. Their staffing rength varies with functions, financial capability and the ligned objectives.

At each level they provide leadership roles in medic.

CURRICULUM AND INSTRUCTIONAL RESOURCED: MEED LAA TEAM APLOACH

Curriculum planning and development are educational intitities of decisions that cannot omit the design and production of intructional resources because they are inter-related. Yet it inot unusual to find that the decision to produce or select be resources is done only at the curriculum implementation level the teacher. This deviation can partly be held accountable of some inadequacies at the curriculum implementation level.

Yellow Planning and development of curriculum and instructional sources function as a team. The representatives of educational stitutions, government ministries, industries, along with ecialists in instruction, psychology, methodology, evaluation, weational technology, guidance and counselling and various bject specialists etc. team up to make instructional resource licy decisions.

At the initial level the needs of the learners, the teacher of the society are assessed. The goals, resources and their ternatives, the constraints, the curriculum scape, sequence delivery systems are considered. The course level deliver

DUCATIONAL FLATHOLOGY IN DENIO: SECONDARY SCHOOL:

Among some innovative approximes applied toward: alveging wrailing educational system, in findings in the field of Mucational Communications and lechnology (ECT) seem to raise the expectations of educational personnel and the Learners. Ulthough these findings are not a panacea for all educational roblems, the expectations are not unjustified. Given Nigeria's concern and the subsequent commitment to be success of the S.S.S Programme, as sketched above, this per therefore attempts to critically examine the problems, aspects and strategies of integrating some findings of ECT to the S.S.S rogramme in an attempt to solve some of the lentified problems. Its focus is therefore on the following tree questions:

(a) Given the current socio-sconomic situation vis-a-vis the existing clucational and pedagogic problems in the country, what instructional resources would be most suitable for the senior secondary school and why?

- 2. Learner Variables: These consist of learner's level of literacy, entry behaviour, attitude, experience, sodin-cultural background, age, etc.
- 3. The Learning Environment: Inia subsumes the available educational infrastructure, finance, learning space, personnel attitude towards innovation, etc.
- instructional resources must meet the available time, budget and personnel which in turn do influence instructional design, implementation and evaluation.
- 5. The Economy and Cultural Setting: Variables in this category consider the available resources, technological skills, availability of electricity, socio-cultural level of users, religious and cultural idiosyncracies, degree of irbanization and acceptability of the instructional resources.
- target audience) level of desired response, seating arrangement, cost-effectiveness, accessibility of media and spare parts, and teacher capability, etc.
- It is important to point out the need, in austere times like this, to plan for the exploration, mobilization and itilization of all forms of community resources for instruction. They include community establishments: museums, ottage industries, poultry farms, zoological gardens, impermarkets, carpentry and other technical workshops, etc. There are the unusual phenomena such as mineral depositions, forest reserves, springs and waterfalls, historic and callural scenes and special sceneries, etc. The next group is the resource persons including the chiefs, national award holders, foreigners, celebrities, clergymen, businessmen and women, teachers, doctors, blue collar jobbers, etc.

 These resources have great instructional potentials.

the units of instruction, distinguishes and specifies objectives. Contents and tasks are analysed, classified, sequenced and relevant media of instruction specified.

At the third level, that is, lesson level, the performance objectives are specified in behavioural terms, modules and modes (media and methods) are developed, implemented and evaluated according to the desired objectives.

The general set-up also considers teacher recruitment, pretraining and in-service training programmes, building and other infrastructural needs to match the learner and immediate societal meds and to reflect the national goals. This approach is based in the systems theory. No big venture had over been successful without adequate systematic planning for all the basic variables it its inception. It is a holistic attempt to ensure proper planning and management of the educational enterprise to ensure the success of the S.S.S Programme.

ROBLEMS AND REMEDIES:

- The following problems and remedies are likely to be contended with:
- the support of the military administration which will subsequently give the necessary financial support for purchase, maintenance and repairs of equipment and the training of personnel. Other sources of finance such as Old Students Associations and PTAs seed to be explored too.
- Mucational Technologists to man and encourage production and stilization of instructional resources in our schools. The re-service training needs of the teacher must. The phasize media production and utilization. Regular a grace in the form of workshops, seminars, week-end courses, etc.

 The bound be encouraged for the serving teachers. These are likely improve teachers attitude to instructional resources and their covision and utilization techniques.
